The *Cost to Educate* a student at All Saints Catholic Academy is approximately \$6,400.00. One of the missions of All Saints Catholic Church and St. Vincent de Paul is the support provided to All Saints Catholic Academy by helping to offset the difference between the 'Cost to Educate' and paid tuition.

### **FACTS Grant and Aid Application Process**

Families seeking ***tuition assistance*** are required to apply through FACTS Grant & Aid, who manages the application process.

- ◆ ***Every family requesting tuition assistance is required annually to complete the FACTS Grant and Aid application.***
- ◆ Only ***verified*** FACTS applications are considered for additional tuition assistance.
- ◆ Building level tuition assistance's Grant and Aid Application deadline is April 15, 2024 for current families and new families registered by April 15, 2024. (Diocesan Scholarships have a Grant and Aid Application deadline of April 1st).
- ◆ New families registering after April 1, 2024 should apply within 2 weeks of registration.
- ◆ Final tuition rates are set after a ***verified*** FACTS application is received.

Please note that FACTS Grant & Aid *does not* determine the award amount; the service simply provides ASCA with a detailed analysis of a family's financial situation along with a recommendation of what FACTS Grant & Aid believes each family should be able to contribute toward the student's education. All of the family's information is kept strictly confidential.

### **FACTS Tuition Management**

All Saints Catholic Academy uses the services of FACTS Tuition Management to collect tuition and fee payments. The process is quick, easy, safe, secure, and Diocesan compliant.

- ◆ ***New ASCA families are required to register with FACTS Tuition Management to schedule their monthly 2024-2025 tuition payments.***
- ◆ *Re-registering families with an active auto-payment account, do not* need to manually re-register for FACTS Tuition payments, as their account will roll over. Invoice accounts need to be transferred to auto payment.
- ◆ *The annual enrollment fee of \$46 will be charged prior to 1<sup>st</sup> tuition payment.*
- ◆ Tuition payments begin in August and are paid monthly (10 or 11 payments) through an automatic withdrawal from a savings, checking, or credit/debit card. If using a credit/debit card additional fees may be incurred.
- ◆ Tuition paid in full is due by 9/10/24 to the school office.
